Saleh's New Conditions For Transition Plan

unmen shot dead an anti-regime unmen snot dead an anti-regime protester Sunday in the Yemeni capital, medics said, as President Ali Abdullah Saleh set new conditions for signing a PGC-brokered plan to end deadly protests against his 33-year-rule.

Members of the opposition said the protester was killed by processine; thuse's who

tester was killed by pro-regime 'thugs' who had blocked roads in Sana'a as hundreds of thousands of Saleh opponents took to the

thousands of Saleh opponents took to the streets, AFP reported.


A statement by Saleh's ruling party said he does not recognize the opposition's sign-ing of the plan as US Secretary of State Hillary Clinton said he 'needs to follow through on his commitment' to cede power in accordance with the proposals from Yem-en's wealthy Persian Gulf neighbors.

But the opposition vowed it would press on with four months of deadly street pro-tests until Saleh signs up to a PGCC-brokered plan for his departure.

"If Saleh does not sign, the revolt will es-calate and he will be thrown out of office," caatae and ne will be thrown out of office.

Mohammed Al-Qahtan, spokesman for the Common Forum opposition umbrella group, told AFP.

Opposition sources said on Saturday that they had signed the accord for Saleh to cede



power, with the president expected to folow suit on Sunday.

The bloodshed came as hundreds of Saleh loyalists armed with batons blocked Saten toyatists armed with batins blocked roads in Sana' a leading to the presidential palace, to the airport and Tahrir Square near government headquarters. Hundreds of thousands of Saleh oppo-nents also took to the streets of Sana'a in

their biggest rally since protests began in

Doctors marched in their white coats while young protesters wore the colors of

while young protesters wore the cotors of the Yemeni flage-red, black and white. Meanwhile, soldiers from the Republi-can Guards, which are led by Saleh's son Ahmed, opened fire on demonstrators wounding seven in Yemen's second-larg-

est city Taez where hundreds of thousands demonstrated demanding Saleh's ouster, witnesses said.

Similar protests erupted across the stra-egic Arabian Peninsula country in Al-Hu-laydah, Ibb, Al-Baida, Marib, Aden and Hadramawt.

State news agency Saba quoted a statement by the ruling General People's Congress (GPC) party as asying that 'the agree-ment must be signed at the presidential palace and in the presence of all concerned political parties'.

An accord 'inked behind closed doors

cannot be recognized and reflects bad intentions', said the statement, apparently referring to the late Saturday signing of the ac-

cord by the opposition.

But Qahtan said, "We will not take part in any signing at the presidential palace."

Under the terms of the proposal, Saleh

vould hand power to the vice president 30 days after the signing, and he and his aides would be granted immunity from prosecu

would be granted immunity from prosecu-tion by parliament.

A national unity government led by a prime minister from the opposition would be formed, and a presidential election would follow 60 days after Saleh's departure.

Israel Approves New Settlements

Israeli Defense Minister Ehud Barak has approved construction of 294 new homes in the West Bank settlement of Beitar Ilit, anti-settlement NGO Peace Now reported on Sunday.Peace Now made its announcement as Prime Min-ister Benjamin Netanyahu was in Washington, preparing to address the US Congress and the powerful pro-Israel lobby, the American Israel Public Af-fairs Committee (AIPAC).

It said Barak also approved building of homes for the elderly and a shopping center in the settlement of Efrat.

The group could not say exactly when Barak signed off on the two projects. In response to AFP's queries, the de-fense ministry issued a brief statement

saying only that 'since the end of the freeze period a few building permits have been approved for communities

situated in the (settlement) blocs to meet their living needs'.

Peace negotiations between Israel and

the Palestinians have been on hold since late September, when a 10-month, par-tial Israeli settlement freeze expired and Netanyahu declined to renew it.

Bomb Blasts Kill 16 in Iraq

More than a dozen bomb attacks in and around Baghdad on Sunday left 16 people dead, including 10 people killed in a suicide attack, and more than 70 wounded. According to AFP, the series of attacks comes just days

One of those mortar rounds exploded, but there were no casualties among UN personnel, Jiang said.

Israeli Attack on American Ship

The Forgotten Crisis

Interview with Phillip F.Tourney, USS Liberty Survivoi Interviewer: Ali A. Jafari aliajafari369@yahoo.cor

Q: Mr. Tourney, we have read the attack on the USS Liberty was to serve as a pretext incident to justify an American attack on Egypt, a pretext to bomb Cairo and other Egyptian cities and add all of Egypt to the 'Greater, or Eretz Israel', as part of a plan called, 'Operation Cyanide'. What can you tell us about that aspect of the attack on the USS Liberty and Operation Cyanide?

PT-Yes, as I said, the plan was to sink our ship, blame it on Egypt as a pretext for the US going to war for Israel's benefit and to drive the Soviets out of the region for good. We know that as an official operation, Cyanide was real, as some of the LIBERTY crew working with the US National Security Agency were briefed on it before we headed out to sea from Norfolk, Virginia, our home port. To my knowl-

before we headed out to sea from Norfolk, Virginia, our home port. To my knowledge however they did not know the whole scope of the operation, obviously, as they would have been participating in their own deaths.

Another thing that your readers, and indeed all persons around the globe need to realize is that there were US bombers in the air headed to Egypt with orders to drop nuclear weapons on Cairo. According to witnesses serving aboard the aircraft carriers from where the bombers were launched, they were a mere 3 minutes away from nuking Cairo. The only reason they did not is because we had not sunk yet, and the US and Israel would have some explaining to do if a nuke was dropped on a major city like Cairo when they were innocent of any wrongdoing. People would have figured out that Israel and America had colluded to sink a US ship and kill all 300 men on board.

Q: Mr.Tourney, let's talk about the media coverage and why the story of USS Liberty has not been and still is not newsworthy. On November 8, 1979, just 4 days after the Iran hostage crisis started, ABC News launched a new program called Nightline, only and specifically to present American viewers with the latest news about American hostages held in Iran on a nightly basis. After 444 days, American hostages came home unscratched, nonetheless, the news coverage and all the sensationalism that went along with it, continued unabated. Ted Koppel invited the hostages to the Nightline numerous times so that they could tell American people about their experience and what happened to them in American embassy in Tehran.

As I indicated earlier, if the American people were to learn the awful truth of what happened to us and the cover-up, it would result in a domino effect that would be deadly for

Israel and her supporters here in the US. All the sudden, Americans, now overwhelmed with the heavy cost of fighting Israel's wars for her in the Middle East would start ask-ing questions about 9/11 and pos-sible American/Israeli collusion in that.  You have mentioned in your book that 'Israel rules America'. You


